**ARTICLES OF INCORPORATION
OF
ATHEISTS AND OTHER FREETHINKERS
A CALIFORNIA PUBLIC BENEFIT CORPORATION**

ONE: The name of this corporation is Atheists and Other Freethinkers.

TWO: (a) This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for public purposes.

(b) The specific purpose for which this corporation is organized is to promote the civic understanding and acceptance of atheism in our community.

THREE: The name and address in the State of California of this corporation's initial agent for service of process is Mynga Futrell, at 1135 Santa Barbara Court, Sacramento, California, 95816.

FOUR: (a) This corporation is organized and operated exclusively for public and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

(b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue.

(c) No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of, or in opposition to, any candidate for public office.

SIX: The property of this corporation is irrevocably dedicated to educational purposes and no part of the net income or assets of the organization shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

On the dissolution or winding up of the corporation, its assets remaining after payment of, or provision for payment of, all debts and liabilities of this corporation, shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for educational purposes and which has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

SEVEN: The name of the existing unincorporated association, now being incorporated by the filing of these Articles of Incorporation is Atheists and Other Freethinkers.
